- Current Operations
 - Current program and enrollment:
 - Half Day: 8 currently (starting in March, 10 children)
 - Emily has made an offer to the substitute teacher to become staff to accommodate more enrollment in the half day program, which currently has a short waitlist.
 - School Day: 16
 - All Day: 15
 - Status of Peacetime Emergency Child Care (PECC) Grants.
 - New round;.
 - Vaccine update: Decided not to require it but encourage it; Heartwood did get spots in the state lottery for vaccination; some of our staff have received the first round of vaccines
 - o Re-enrollment is underway and is looking great so far.
